

Transcript-Interview to Witness Rose Lords

Detective: Today's date is Tuesday on June 02, 2009; the time is 2: 17 AM. This is in records to a homicide investigation that occurred earlier last night actually on Monday, June 01, 2009 to Murder investigation that occurred at: 999 BLANK Drive. The victim being Laura Perez. First in the interview right now is Ms. Rose: R-O-S-E, Middle name BLANK : last name Lords: L-O-R-D-S. She is a Hispanic female, date of birth 01/01/1920. She is the next door neighbor that lives to the right of the occurrence. She lives at: 999 BLANK Drive, California; she has a contact number area code 7999999999 which is her cell phone. My name is detective Pepito Lopez with the California BLANK Police Department Homicide Unit, this will be conducted by the Law Enforcement Center on the third Floor in the victim's room assistance; 999 No St., BLANK, California. This will be conducted in Spanish as Ms. Lords speaks Spanish just as her primary language and I am Spanish speaker detective. Ms Lords: Do you speak English?

M=Ms. Lords

P= Detective Lopez

M: Not at all.

P: Not at all, well. Mmm... OK my name is detective Pepito Perez. I'm a detective here with the Police Department and I am in charge of the investigation of this girl who died today. Mmm... Let's see, explain to me what do you know about what has happened today.

M: What happened is that on Saturday...

P: OK

M: On Saturday, we are already asleep when someone knocked on the door and it was Jennifer, it was the girl with the child and told me Mrs. Rose let me get inside your house because Robert grabbed a gun and she tried to snatch it and the father of the child came to visit....

P: Who grabbed the gun?

M: I think the gun was shot and then it fell to....

P: To whom did he shoot?

M: She had the gun; she told me that she had it this way but the husband came. Something like that happened.

P: Mmm....

M: She told me like that, but then when I, when I....

P: Who had the gun her or Robert?

M: Robert.

P: OK

M: Robert had it.

P: And Robert shot the gun?

M: I think it was shot, she told me that it had fired, nothing more....

P: To whom did Robert shot?

M: She did, I don't know... She told me so, he brought the gun and he was carrying it like this, but the husband...

P: But he was carrying it or he pointed it at her?

M: To her, to her.

P: OK OK, then, so....

M: Yes.

P: Then Laura told you that Robert had the gun and he put it...

M: Aha.

P: To the how it is called neck....

M: Aha.

P: On Laura

M: On Laura

P: OK

M: But I think her husband came and the gun fell off, that is what she told me. Then I told her so you stay here, I won't open the door but I left and it's when the police arrived.

P: Ummm

M: I was told by the police that if in case.... And he ran, he fled.

P: Who?

M: Robert.

P: OK

M: And from there is when the police gave me this business card....

P: Umm

M: Just in case something happened. Once they were all gone, he returned.

P: Umm

M: And he wanted to get inside my house.

P: He wanted to get inside your house?

M: He wanted to get inside my house but I did not let him do it and when he pushed me like this well my husband was already there so we kicked him out.

P: Umm

M: The next day on Sunday he was stubborn that he wanted to me to talk to her and I called my daughter because this boy was so stubborn and I told my daughter everything that has happened and she came to my house. The police arrived again and my daughter told them that she doesn't want to see him around the house that maybe restrictions should take place because I am alone in the house sometimes and he seems not to understand it.

P: So Robert forced himself inside the house? He forced himself?

M: Yes he came in, he got inside the house to talk to her but we did not let him in.

P: Umm

M: Then he insisted by knocking on the windows but I told him don't do that. If you insist I would call the police on you.
