MEDICAL REPORT

By means of the present report, it is informed that the patient has been examined at our medical institution for the past 4 months (from July 1st, 2010 to November 2010). The patient has been diagnosed with polytrauma, multiple excoriations on the face, tumefaction of both cheeks, edema, swelling and contusion of the chin, as well as excoriations on the thorax and the left breast with swelling on the latter.

Consequently, the patient is advised to fully rests for two months, and to take the following medications as part of the treatment: Dexametasone Amp., Naproxen 550 mg. tab., Hanalgeze 60 mg, and Ciprofloxacin 500 tab.

Starting on January of 2010, the patient has been coming back to our institution periodically on a monthly basis for treatment due to the diagnosis of back pain and lumbar pain syndrome, which causes the patient to have difficulties walking due to pain. Thus, we prescribed performing complementary laboratory exams and neurological tests. In addition, we have performed radiology tests of the vertebral column.

We recommend the patient to be assessed by a Neurologist. Currently, the patient's prescribed treatment is: Naproxen tab, Hanalgeze in tab. Doloneurobion in tab, Norflex in tab.
